Tuition & Financial Responsibility Agreement

This form serves as a formal financial agreement between **New Life Academy** and the undersigned Parent/Guardian regarding tuition responsibility for the following student(s):

By enrolling your student at New Life Academy, you acknowledge and agree to the terms outlined below.

Tuition is **required upon enrollment**. Enrollment constitutes acceptance of a **binding financial obligation for the full academic year**, regardless of whether the student attends New Life Academy for the entire year. The full annual cost of tuition is owed and may be paid either **monthly**, according to the school's tuition schedule, or **in full annually**, if elected.

This obligation remains in effect even if the student withdraws, is dismissed, or otherwise stops attending New Life Academy for any reason. **Non-attendance does not release the Parent/Guardian from financial responsibility**, and no refunds or reductions will be issued once enrollment has occurred.

If your student receives the **North Carolina Opportunity Scholarship**, funds are generally issued directly to New Life Academy. However, please understand that the tuition agreement is **solely between you and New Life Academy**. Scholarship funding does not replace or transfer your financial responsibility. Please see Student Handbook for Military exceptions.

In the event that scholarship funds are delayed, reduced, revoked, discontinued, or do not cover the full tuition amount, the Parent/Guardian remains **fully responsible for the remaining balance**.

Failure to meet tuition obligations may result in actions including, but not limited to, withholding of student records, suspension or termination of enrollment, and referral to collections or legal action as permitted under North Carolina law.

This agreement shall be governed by and construed in accordance with the laws of the **State of North Carolina**. This letter represents the entire agreement regarding tuition and financial responsibility and supersedes any prior written or verbal understandings.

By signing below, you acknowledge that you have read, understand, and agree that **tuition is required upon enrollment and is a binding, full-year financial obligation**, regardless of attendance.
